MUNICIPAL ORDINANCE NO. 246

AN ORDINANCE RE-NAMING SITIO BAGBAGO BASSIT/MAIGAT INTO
SITIO DE LARA IN HONOR OF THE LATE FEDERICO DE LARA.

WHEREAS, Resolution No. 15 of the Barangay Council of
Laureta, Solsona, Ilocos Norte recommended to the Sangguniang
Bayan of Solsona, Ilocos Norte re-naming Sitio Bagbago Bassit/
Maigat into Sitio de Lara in Honor of the Late Federico de Lara;

WHEREAS, RA 7160, Section 13 (c) (1) the Sangguniang of
component cities and municipalities in consultation with the Philip-
pine Historical Commission, change the name of the following within
its territorial jurisdiction city and Municipal Barangays upon re-
commendation of the Sangguniang Barangay concerned;

WHEREAS, upon consultation with the National Historical
Institute, Resolution No. 15 of Barangay Laureta, Solsona, Ilocos
Norte be accommodated and interposes no objection to such proposal;

NOW THEREFORE, on Motion of Hon. Henry A. Batara, unani-
mously seconded by all the members;

Be it Ordained by the Sangguniang Bayan of Solsona, that:

Section 1 - Sitio Bagbago Bassit/Maigat will be re-named
Sitio de Lara in Honor of the Late Federico de Lara;

Section 2 - This Ordinance shall take effect TWENTY (20)
days after posting at conspicuous places and publication of news-
paper of Local circulation;

the Barangay Of Laureta, Solsona, Ilocos Norte for their information.
