MUNICIPAL ORDINANCE NO. 303

AN ORDINANCE GRANTING FRANCHISE TO SOLSONA CABLE TV
TO CONSTRUCT, INSTALL AND OPERATE CABLE TV NETWORK
WITHIN THE POBLACION AND NEARBY PLACES OF THE MUNI-
CIPALITY OF SOLSONA, ILOCOS NORTE.

WHEREAS, presented for consideration and deliberation
to the August Body was the application of Solsona Cable TV, repre-
sented by Mr. Alfredo P. Juan for franchise to operate Cable TV
within the Poblacion and nearby places of the Municipality of
Solsona, Ilocos Norte;

WHEREAS, after a lengthy discussion and through examina-
tion, the Body deemed it wise to grant the franchise;

WHEREFORE, on motion of Hon. Luis B. Ganal, duly seconded
by Hon. Antolin D. Refani and Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - The Solsona Cable TV represented by Mr.
Alfredo P. Juan, otherwise known as the grantee shall provide its
subscriber members with live and clear television signal of all
existing local television stations including but not limited to CNN,
BBC and Star TV transmitted programs;

Section 2 - The Grantee shall maintain and operate along
with nationally transmitted programs an IN HOUSE CHANNEL to air public
affairs, news bulletines and selected programs;

Section 3 - The Grantee shall maintain and establish such
towers and repeaters as well as other frequency channels for distribu-
tion by Cable and such other communications facsimile as maybe feasible;

Section 4 - The Grantee shall submit to the Office of the
Municipal Mayor the antenna diagrams and specification with the truck
cable distribution plan within three (3) months from the grant of this
franchise and make the system operational within a period of one (1)
year there from;

Section 5 - The Municipal Government of Solsona, Ilocos
Norte shall collect from Grantee, Service Tax, Business Tax Fees and

other charges, annual permits to operate the business and such other duties and charges as shall from time to time be levied by law or ordinance;

Section 6 - A "right of way" over all municipal government properties is expressly given to herein GRANTEE in so far as the installation of truck cable facilities is concerned, provided that inspallation thereof on the account of the Grantee and shall not in any manner, prejudice government existing facilities and services;

Section 7 - The GRANTEE shall retain full ownership for all its installed facilities including cable lines and other accessories upon the expiration of the franchise;

Section 8 - In case of increase in the monthly fee, the Solsona Cable TV shall inform the Sangguniang Bayan and its clientele in writing prior to said increase;

Section 9 - The franchise shall be exercise for a period of ten (10) years from and after approval of this Ordinance with options on the part of the GRANTEE to apply for the renewal of the same with the concurrence of the Sangguniang Bayan and of the GRANTOR to pre-terminate the franchise after due notice for serious violations of law for poor services rendered or of the terms of the franchise hereto given;

Section 10 - This Ordinance shall take effect after the lapse of twenty-one (21) days posting in three (3) conspicuous places in the bulletin board, church and market and publication in the local news paper;

Copies of this resolution be furnished the Sangguniang Panlalawigan, Laoag City, Mr. Alfredo P. Juan, Barangay Manalpac, Solsona, Ilocos Norte and others concerned for their information and consideration;

CARRIED UNANIMOUSLY, with the following votes:


