MUNICIPAL ORDINANCE NO. 304

AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO DONATE
A PARCEL OF LAND OWNED BY THE MUNICIPAL GOVERNMENT TO
THE BARANGAY GOVERNMENT OF LAURETA, SOLSONA, ILOCOS
NORTE WITH AN AREA OF 2000 SQUARE METERS WHICH IS
BEING OCCUPIED BY THE MULTI-PURPOSE PAVEMENT NAMED
FEDERICO DE LARA PARK.

WHEREAS, pursuant to Article 87, (VI) of the IRR-RA 7160,
the Municipal Mayor upon authorization by the Sangguniang Bayan,
shall represent the municipality in all its business transactions
and sign on its behalf all bonds, contracts, obligations, and such
other documents made pursuant to law or ordinance;

WHEREFORE, on motion of Hon. Henry A. Batara, duly second-
ed by Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1- The Municipal Mayor, Hon. Joseph E. de Lara, on
behalf of the Municipal Government of Solsona, Ilocos Norte is hereby
authorized to donate a parcel of land owned by the Municipal Government
to the Barangay Government of Laureta, this municipality, with an area
of 2000 square meters which is being occupied by the Multi-Purpose
Pavement named "Federico de Lara Park";

Section 2 - This Ordinance shall take effect after the
lapse of twenty-one (21) days and posting in three (3) conspicuous
places;

Copies of this Ordinance be furnished the Sangguniang Pan-
lalawigan, Laoag City for their information and consideration;




