MUNICIPAL ORDINANCE 313

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES, LAOAG BRANCH, LAOAG CITY, REPRESENTED BY MR. FRANCISCO B. DOMINGO, DM III/HEAD BCG, FOR A SALARY LOAN AND VEHICLE FINANCING PROGRAM FOR LOCAL GOVERNMENT UNIT (LGU) OFFICIALS AND EMPLOYEES.

WHEREAS, pursuant to the provisions of Article 87, Section VI of the IRR, RA 7160 the Sangguniang Bayan is empowered to grant authorization to the Local Chief Executive to represent the Municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made;

WHEREFORE, on motion of Hon. Henry A. Batara, duly seconded by Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan, Solsona, Ilocos Norte, that:

Section 1 - The Local Chief Executive, Hon. Joseph E. de Lara, is hereby granted the authority to enter into a Memorandum of Agreement with the Development Bank of the Philippines, Laoag Branch, Laoag City, represented by Mr. Francisco B. Domingo, DM III/Head, BCG;

Section 2 - This Ordinance shall take effect immediately upon approval;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and to all concerned for their information and consideration;


