MUNICIPAL ORDINANCE NO. 319

AN ORDINANCE REQUIRING APPLICANTS FOR A MARRIAGE LICENSE
TO PLANT AT LEAST FOUR (4) FRUIT BEARING/NON-FRUIT BEARING
TREE SEEDLINGS AS A PRE-REQUISITES IN THE ISSUANCE THEREOF.

WHEREAS, the Municipality of Solsona, Ilocos Norte having
been adjudged the Cleanest and Greenest Town in the Province of Ilocos
Norte needs to maintain its name;

WHEREAS, there shall be a continues planting of trees in
all the barangays in support to the Clean and Green Campaign;

WHEREFORE, on motion of Hon. Adlai C. Factors, duly seconded
by Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte,
that:

Section 1 - Applicants for Marriage Licenses be required to
plant at least four (4) Fruit Bearing/non-fruit bearing tree seedlings
before the issuance thereof;

Section 2 - A certification from the concerned Barangay Cap-
tain to be submitted to the Municipal Civil Registrar as a pre-requisite
in the issuance of a marriage license;

Section 3 - This Ordinance shall take effect after the lapse
of 21 days after posting copies in three (3) conspicuous places and
upon publication in a newspaper of local circulation;

lawigan, Laoag City and others concerned for their information and
consideration;


