MUNICIPAL ORDINANCE NO. 327

AN ORDINANCE REGULATING THE NUMBER OF HEAD OF HOGS  
TO BE RAISED BY EVERY HOUSEHOLD WITHIN THE URBAN  
BARANGAYS AND PROVIDING PENALTIES IN VIOLATION  
THEREOF.

WHEREAS, health is an important factor in the socio-  
economic upliftment of the community;

WHEREAS, to support the Clean and Green Program of the  
government that all creeks, rivers and canals shall be free from  
contamination and pollution;

WHEREAS, Solsona is fast progressing and becoming the  
center of trade and industry;

WHEREAS, to safeguard health and sanitation of the  
populace of the urban barangays there is a need to regulate the  
number of head of hogs to be raised on every household;

WHEREFORE, on motion of Hon. Gervacio B. Vicente, duly  
seconded by Hon. Henry Batara and Hon. Agripino Estavillo, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos  
Norte:

Section 1 - That the number of hog to be raised in every  
household shall be one (1) sow/boar and two (2) fattener;

Section 2 - That all pigpens shall have septic tanks  
to ensure that it will not emit foul odors;

Section 3 - Any household violating this Ordinance  
shall be fined of not less than FIVE HUNDRED PESOS but not more  
than ONE THOUSAND PESOS (P1,000.00) or an imprisonment of not  
less than one (1) month but not more than six (6) months or both  
upon the discretion of the court;

This Ordinance shall take effect after the lapse of  
twenty-one (21) days upon posting in three (3) conspicuous places  
and publication in a newspaper of local circulation;

Copies of this Ordinance be furnished the Sangguniang  
Panlalawigan, Lacag City, for their information and consideration;


