MUNICIPAL ORDINANCE NO. 35

AN ORDINANCE REQUIRING ALL PERSON OR PERSONS TO HAVE THEIR
DOGS BE VACCINATED WITH ANTI RABIES VACCINE.

WHEREAS, according to the records of the Rural Health
Office there were many victims inflicted with rabies caused
by dog bites;

WHEREAS, to protect the people from rabies, it is
necessary to require all dog owners to have their dogs be
vaccinated with Anti-Rabies Vaccine;

WHEREAS, the Bureau of Animal Industry had granted
the municipality its request to have anti-rabies vaccination of
all dogs in this area through the help of the personnel of the
Department of Agriculture, stationed in this municipality;

NOW THEREFORE, on motion of Hon. Henry Batara, secon-
ded by Hon. Conrado Castueras, be it

ORDAINED by the Sangguniang Bayan of Solsona, Ilocos
Norte that:

Section 1 - All dog owners are required to have their
dogs be vaccinated with anti-rabies vaccine;

Section 2 - Dog owners who fail to have their dogs be
vaccinated will be fined of P100.00 but not more
than P300.00 or both fine and imprisonment upon the description
of the court;

Section 3 - This ordinance shall take effect after the
lapse of ten (10) days from the date a copy of it is posted in
a bulletin board, located in a conspicuous place at the Muni-
cipal Hall, at the different barangay halls, Public Market and
all churches in the municipality and upon the approval of the
Sangguniang Bayan for their approval and consideration.

RESOLVED FINALLY, to transmit copies of this Municipal
Ordinance to the Sangguniang Panlalawigan, Laoag City for their
information and consideration;
