MUNICIPAL ORDINANCE NO. 38

AN ORDINANCE REQUIRING TRICYCLE DRIVERS TO REGISTER AT THE  
PNP SOLSONA HEADQUARTERS BEFORE TRANSPORTING COMMUTERS OUT  
OF THE POBLACION OF SOLSONA, ILOCOS NORTE AND OUT OF TOWN  
AT NIGHT TIME AND AT DAWN.

WHEREAS, according to radio broadcasts and news-  
paper reports, there are cases of kidnappings/murders/robbe-  
ries of tricycle drivers or commuters in some towns, parti-  
cularly Laoag City while they transport passengers out of  
town at night time;

WHEREAS, there is a need to protect the tricycle  
drivers/commuters for probable consequences of kidnappings,  
murders and robberies while transporting passengers at night  
and at dawn;

WHEREAS, to avoid such eventuality, it is deemed  
necessary to enact a measure for this purpose;

On motion of Member Henry Batara, duly seconded  
by Member Alma Manuel, be it

ORDAINED, by the Sangguniang Bayan of Solsona,  
Ilocos Norte, that:

Section 1 - All tricycle drivers are required to  
register at the Solsona PNP Headquarters before transporting  
commuters out of the Poblacion of Solsona, Ilocos Norte at  
night time or at dawn;

Section 2 - Any tricycle driver who violates this  
Ordinance shall be fined as follows: ONE HUNDRED PESOS (P100.00)  
for the first offense, TWO HUNDRED PESOS (P200.00) for the  
second offense and THREE HUNDRED PESOS (P300.00) for the 3rd  
offense or shall be banned to hire for a period of one (1)  
month;

Section 3 - This Municipal Ordinance shall take  
effect upon the lapse of ten (10) days, a copy of which  
will be posted at a conspicuous places at the Municipal  
Building, All Barangay Halls, the Public Market, waiting  
sheds and all churches;
