MUNICIPAL ORDINANCE NO. 385

AN ORDINANCE IMPOSING A MONTHLY RENTAL FEE OF FIVE
HUNDRED PESOS (P500.00) OF THE PERMANENT STALLS.

WHEREAS, the newly constructed Solsona Market Permanent
Stalls is now available for occupancy;

WHEREAS, there shall be a monthly rental fee of the old
and new permanent stalls;

NOW THEREFORE, on motion of Hon. Andresito A. Luis, duly
seconded by Hon. Adlai C. Factora, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - The monthly rental fee of the permanent stalls
shall be FIVE HUNDRED PESOS (P500.00);

Section 2 - All Ordinances or parts thereof inconsistent
herewith are deemed repealed, rescind or modified accordingly unless
the same provides for a higher rate;

Section 3 - This Ordinance shall take effect after the lapse
of twenty-one (21) days from the day a copy of it is posted in a
bulletin board located in three conspicuous places and publish for
three (3) consecutive weeks in a newspaper of local circulation;

Copies of this Ordinance be furnished the Sangguniang
Panlalawigan, Laoag City and all concerned for their information and
consideration;




