MUNICIPAL ORDINANCE NO. 386

AN ORDINANCE DECLARING EVERY 27TH DAY OF FEBRUARY OF
EVERY YEAR AS FREE CIVIL REGISTRATION DAY.

WHEREAS, February of every year was declared as Civil
Registration Month by the President of the Philippines under
Proclamation No. 082, dated January 28, 1991;

WHEREAS, the celebration of the Civil Registration Month,
reminds the people the value and importance of the Civil Registra-
tion System;

NOW THEREFORE, on motion of Hon. Henry A. Batara, duly secon-
ded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - Every 27th day of February of every year shall
be declared as the Civil Registration Day;

Section 2 - Civil Registry Certification shall be issued
free of charge to the public;

Section 3 - No civil registration shall be collected from
the registrants except applications for marriage license;

Section 4 - This Ordinance shall take effect three (3)
weeks after it is posted on the bulletin board located at the
Municipal Hall and other conspicuous places and after publication
in a newspaper of local circulation;

Copies of this Ordinance be furnished the Sangguniang
Panlalawigan, Laoag City and the National Statistics Office, Laoag
City for their information;


