MUNICIPAL ORDINANCE NO. 40

AN ORDINANCE PROHIBITING RETAIL STORES OF THIS MUNICIPALITY FROM SELLING FIRECRACKERS.

WHEREAS, firecrackers are destructive and dangerous to lives and properties;

WHEREAS, it is well known nationwide that several people met an accident due to firecrackers, especially during New Year's Eve;

NOW THEREFORE, on motion of Vice-Mayor Pablito Cabacungan, duly seconded, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Iloilo Norte, that:

Section 1 - Selling firecrackers in all retail stores shall be prohibited;

Section 2 - That any owner of retail store, person caught in possession of the above-mentioned explosives shall be subjected to the penalties as provided for in this Ordinance;

Section 3 - Any infraction of violation of this Ordinance shall be fined for not less than P50.00 but not more than P100.00 or an imprisonment of ten (10) days but not to exceed 20 days, or both fine and imprisonment at the discretion of the Court;

Section 4 - This Ordinance shall take effect after the lapse of 10 days from the date a copy of it is posted in a bulletin board located at the Municipal Hall, Barangay Hall and other conspicuous places in town;

Voting on the foregoing Ordinance as follows:
