ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte

Section 1- The first Monday of every month shall be de-

shall be fined of not less than TEN PESOS (P10.00) but not more
than TWENTY PESOS (P20.00) or an imprisonment of not less than
two (2) days but not more than five (5) days or both at the dis-
