MUNICIPAL ORDINANCE NO. 411

AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR, HON. JOSEPH E. DE LARA TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE, REPRESENTED BY THE REGIONAL DIRECTOR, HON. ROGELIO SIGNEY.

WHEREAS, the Sangguniang Bayan is empowered to grant authorization to the Municipal Mayor to represent the Municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents made as mandated in the provisions of Republic Act 7160;

WHEREFORE, on motion of Hon. Henry Batara, duly seconded by Hon. Jovencio Pascua and by virtue of the power vested upon the Sangguniang Bayan, pursuant to the provisions of Republic Act 7160, be it ORDAINED, that:

Section 1 - The Municipal Mayor, Hon. Joseph E. de Lara is hereby authorized to enter into a Memorandum of Agreement with the Department of Agriculture, represented by the Regional Director of Region I, Hon. Rogelio Signey, pursuant to Memorandum No. 124 dated 1993, directs all Governors and Mayors to make available to the Department of Agriculture the devolved agricultural extension services for the implementation of the Grains Production Enhancement Program, now known as the Gintong Ani Program;


Section 2 - This Ordinance shall take effect upon approval;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, the Regional Director, Hon. Rogelio Signey, Region I, San Fernando, La Union, for their information and consideration;


