MUNICIPAL ORDINANCE NO. 413

AN ORDINANCE REQUIRING SANGGUNIANG BARANGAYS HEADED BY THEIR RESPECTIVE PUNONG BARANGAY TO DETECT AND PREVENT ILLEGAL CONSTRUCTION AND REPAIR OF BUILDINGS/STRUCTURES WITHIN THEIR AREA OF RESPONSIBILITY AND REPORT THE SAME WITHIN 24 HOURS TO THE DESIGNATED BUILDING OFFICIAL, OFFICE OF THE MAYOR OR THE POLICE STATION AND HAS JURISDICTION OVER IT.

WHEREAS, the erection, construction, repair, conversion or demolition of any building or structure is illegal if the person, firm or corporation engaged thereto have not obtained a Building Permit or without the order of competent authorities to cause the same to be done;

WHEREAS, it has been the problem of the Deputized Municipal Building Official and the Zoning Administrator that illegal constructions, repair, conversion or repair of buildings or structure in the Barangays are not reported to authorities concerned;

WHEREFORE, on motion of Hon. Adlai C. Factors, duly seconded by Hon. Alma B. Manuel, be it ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - All Sangguniang Barangays headed by their respective Punong Barangay are required: a. to detect and prevent illegal construction, repair, conversion of any building structure within their area of responsibility and b. to stop construction of any building without necessary building permit, zoning clearance, as provided for by law;

Section 2 - Zoning Permit and Building Permit are the requisites before such construction, repair or demolition is to be done and the Sangguniang Barangays concerned shall demand the person, firm or corporation engaged thereto the presentation of permit issued;

Section 3 - This Ordinance shall take effect upon the lapse of twenty-one (21) days and upon posting in the Municipal Bulletin Board and other conspicuous places and after publication in a newspaper of local circulation;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all Punong Barangays of Solsona, Ilocos Norte, for their information and consideration;
