MUNICIPAL ORDINANCE NO. 414

AN ORDINANCE NAMING THE HANGING BRIDGE IN BARANGAY
NO. 13, NALASIN, SOLSONA, ILOCOS NORTE INTO DON
FEDERICO DE LARA BRIDGE.

WHEREAS, Resolution No. 09, dated April 14, 1996 of
the Barangay Council of No. 13, Nalasin, Solsona, Ilocos Norte,
recommended to the Sangguniang Bayan of Solsona, Ilocos Norte,
naming the hanging bridge in Barangay 13, Nalasin to Don Federico
de Lara Bridge;

WHEREAS, after a perusal of the measure and because of
its laudable purpose, the Body interposes no objection to such
proposal;

NOW THEREFORE, on motion of Hon. Jovencio M. Pascua,
duly seconded by Hon. Alma B. Manuel, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - The hanging bridge of Barangay No. 13,
Nalasin, Solsona, Ilocos Norte is hereby named "DON FEDERICO DE
LARA BRIDGE;

Section 2 - This Ordinance shall take effect 21 days
after posting at a conspicuous places and publication in a
newspaper of local circulation;


Copies of this Ordinance be furnished the Sangguniang
