MUNICIPAL ORDINANCE NO. 420

AN ORDINANCE REQUIRING OWNERS OF THE BUSINESS ESTABLISHMENTS AND ALL LOCAL TRADERS INCLUDING MARKET VENDORS OPERATING WITHIN THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE FOR MASS STANDARIZATION OF THEIR WEIGHING SCALES THROUGH CALIBRATION AND PENALIZING OWNERS FOR NON-COMPLIANCE THEREOF.

WHEREAS, the municipality has to adopt the standard calibration of weighing scales in order to achieve protection to consumers and to prevent local traders and market vendors from tampering their weighing scales;

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Edison E. de Lara, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - to maintain national standard of measurements, all local traders including market vendors operating within the jurisdiction of the municipality of Solsona, shall, before using their weighing scales should submit first for calibration;

Section 2 - weighing scales for consumer related transactions shall be calibrated every six (6) months in the Office of the Municipal Treasurer through the designated Calibrating Officer with the corresponding fee, as follows:

Less than 30 kgs.	- ₱ 40.00
More than 30 kgs but not to exceed 60 kgs.	- ₱50.00
More than 60 kgs but not to exceed 100 kgs.	- 75.00
More than 100 kgs	- 100.00

Section 3 - Violation of this Ordinance shall subject the proprietor to a fine of ONE THOUSAND (₱1,000.00) PESOS or an imprisonment of fifteen (15) days or both at the discretion of the court;

Section 4 - This Ordinance shall take effect after the approval and after all the requirements provided for in the Local Government Code of 1991 are complied with;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and the Municipal Treasurer, Solsona, Ilocos Norte, for their information and consideration;


