MUNICIPAL ORDINANCE NO. 43

CREATING THE POSITIONS OF MUNICIPAL ACCOUNTANT, MUNICIPAL CIVIL  
ENGINEER AND MUNICIPAL CIVIL REGISTRAR AS PROVIDED FOR UNDER THE  
PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991, RA 7160.

WHEREAS, the Local Government Code of 1991, R.A. 7160,  
provides for the creation of the Municipal Accountant, Municipal  
Civil Engineer and Local Civil Registrar;

WHEREAS, there is an available fund for their salaries  
and Representation Allowance and Travelling Allowance (RATA);

NOW THEREFORE, be it ORDAINED, by the Sangguniang Bayan  
of Solsona, Ilocos Norte, that:

Section 1 - There is hereby created the position of  
Municipal Accountant, Municipal Civil Engineer and Local Civil  
Registrar;

Section 2 - QUALIFICATIONS:

2A - Municipal Accountant - A certified Public Accountant at least 3 years experience in Treasury of Accounting services;

2B - Municipal Civil Engineer - A licensed Civil Engineer and with 3 years of experience in the practice of his profession as Civil Engineer;

2C - Local Civil Registrar - Completion of 4 years in college studies. Experience in Civil Registry work for at least 3 years; First Grade CS Eligible or its equivalent;

Section 3 - Grade Compensation: The Municipal Accountant, Municipal Civil Engineer and Local Civil Registrar receive a grade compensation of Grade 24;

Section 4 - This Ordinance shall take effect on January 1, 1992;

Voting on the foregoing Ordinance as follows:

Against - None.


