MUNICIPAL ORDINANCE NO. 434

AN ORDINANCE REQUIRING KULIGLIG OWNERS TO INSTALL REFLECTORIZED GADGETS AND OTHER AMENITIES FOR TRAFFIC GUIDE/WARNING DEVICES TO THEIR KULIGLIGS AND ITS TRAILER AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, farmers with motorized farm equipment commonly known as "KULIGLIG" oftenly used them to transport their farm products to the commercial district of the municipality and to nearby municipalities especially during the night;

WHEREAS, people tend to use this machinery due to the unavailability of vehicles for hire especially those from the remote areas and some could not afford to pay the rentals offered for by private vehicles;

WHEREAS, it has been observed and reports indicate that several accidents in the provincial roads, municipal roads and main thoroughfares within the municipality are caused by the absence of warning devices of Kuligligs;

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Adlai C. Factors, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - All Kuliglig with trailers shall be installed with reflectORIZED gadgets and other amenities for warning/traffic guide purposes.

Section 2 - Violators of this Ordinance will be apprehended and fined for ONE HUNDRED (P100.00) PESOS or an imprisonment for not less than five (5) days for each offense or both upon the discretion of the court.

Section 3 - This Ordinance shall take effect upon approval and all the provisions of the Local Government Code pertaining there to shall be complied with.

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and All Agencies concerned for their information and consideration;
