MUNICIPAL ORDINANCE NO. 44

AN ORDINANCE REQUIRING TRICYCLE OWNERS TO SECURE FRANCHISE
TO OPERATE IN THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE.

On motion of Member Henry Batara duly seconded,
be it

ORDAINED, by the Sangguniang Bayan of Solsona,
Ilocos Norte, that:

Section 1 - All public utility tricycle owners
operating within the territorial jurisdiction of Solsona,
are hereby required to secure a Municipal Franchise to
operate as pre-requisite in the issuance of a Mayor's
Permit;

Section 2 - The Municipal Franchise to operate
shall be issued by the Municipal Mayor or his duly authorized
representative;

Section 3 - "Validity" - The Municipal Franchise
shall be valid for a period of two (2) years from the date
of issuance;

Section 4 - The following are the requirements in
securing a Municipal Franchise to operate a public utility
tricycle:

- a. Mayor's Permit
- b. Valid Land transportation office registration
- c. Franchise Fee of P150.00
- d. Service fee of P20.00

Section 5 - All petitions to secure a Municipal
Franchise shall be subject to appropriate public hearings;

Section 6 - This Ordinance shall be subject to
review in accordance with the guidelines as may herein
after be issued by the Department of Transportation and
Communications (DOTC);

Section 7 - Any person found violating this Ordinance shall be liable to a fine of ONE THOUSAND PESOS

(P1,000.00) or an imprisonment of arresto minor (1 to 30 days) or both at the discretion of the Court;

Section 8 - This Ordinance shall take effect after the lapse of ten (10) days from the date a copy of it is posted in a bulletin board located in a conspicuous place at the Municipal Hall, Public Market, Catholic Church and at the Barangay Hall, etc.;

Voting on the foregoing Ordinance as follows:

In favor - 9, Against - 0

Copies of this Ordinance be furnished the Chairmen, Committee on Laws, Sangguniang Panlalawigan, the Department of Transportation and Communications (DOTC) Laoag City and other concerned for their information and consideration;
