MUNICIPAL ORDINANCE NO. 444

AN ORDINANCE BANNING NOISY DRINKING SPREES AND EXCESSIVE  
REVERLY MAKING AND PROVIDING PENALTIES IN VIOLATION  
THEREOF.

WHEREAS, quarrels are oftentimes caused by the noisy conduct  
of revelries and drinking sprees which disrupts peace in neighborhoods;

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, duly se-  
conded by Hon. Alma B. Manuel, be it

ORDAINED, by the Sangguniang Bayan in session, that:

Section 1 - Noisy drinking sprees and excessive revelry  
making which covers:

a. Those occasions attended by a group of people  
and accompanied by drinking of liquor, singing and other  
acts of jubilation;

b. During such sessions and celebrations, home-  
owners are prohibited to play stereos, karaokes, video-oke,  
cassettes and radios beyond the normally accepted sound  
modulation after 10:00 P.M. until 6:00 A.M.;

c. Residents creating unnecessary noises and in-  
dulging in any activity which tends to create such noises  
is hereby prohibited;

Section 2 - Birthdays, anniversaries and fiestas are hereby  
exempted;

Section 3 - Violators of this Ordinance shall be fined for  
FIVE HUNDRED PESOS (P500.00) or imprisonment for 15 days or both  
upon the discretion of the court;

Section 4 - The Local Police, Barangay Officials and Tanods  
and accredited Associations will act as enforcers if a complaint is  
made;

Section 5 - This Ordinance shall take effect immediately  
upon approval and all the provisions of the Local Government Code  
pertaining thereto shall be complied with;

Copies of this Ordinance be furnished the Sangguniang Pan-  
lalawigan, Laoag City and all concerned for their information and  
consideration;




