MUNICIPAL ORDINANCE NO. 445

AN ORDINANCE DESIGNATING THE PARKING, LOADING AND
UNLOADING AREAS OF PUBLIC UTILITY AND PRIVATE VEHI-
CLES AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, recent observations of traffic movement along the
commercial district of the Municipality of Solsona had become con-
gested especially during market days;

WHEREFORE, on motion of Hon. Gervacio B. Vicente, duly
seconded by Hon. Agripino Estavillo and Hon. Alma Manuel, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - The parking areas, loading and unloading areas
of all motorized vehicles along the national roads south and east
of the old public market and along identified municipal streets
are hereby relocated;

ARTICLE I - TRICYCLE FOR HIRE:

a. Tricycle for hire bound to Barangays Talugtog, Nalasin,
Barcelona, Aguitap, etc., shall be stationed at the eastern part of
the Public Market along the national highway corner Viloría Street;

b. Tricycles for hire bound to Barangays Puttao, Bagbago,
Santiago, etc., shall be stationed at the western part of the public
market corner National Road;

c. Tricycles for hire bound to Barangays Maananteng,
Catangraran, Manalpac, Mariquet, etc., shall be stationed along the
Gomez Street corner National Road;

ARTICLE II - PUBLIC UTILITY JEEP FOR HIRE (PUJ)

a. Loading/Terminal for PUJ's bound to Laoag City shall
be parked at the southern part of the new public market;

b. Unloading of passengers shall be designated at the
national highway west of the new public market;

c. Parking, loading and unloading for buses bound for
Manila shall be along the Rizal Street;

Section 2 - Loading or unloading of goods of any type of
vehicles in front of the old and new permanent stalls shall be per-
mitted for five (5) minutes;

Section 3 - Violators of this Ordinance shall be fined
for TWO HUNDRED PESOS (P200.00) or an imprisonment of not less than
ten (10) days but not more than fifteen (15) days or both upon the
discretion of the court;

Section 4 - This Ordinance shall take effect upon the lapse of twenty-one (21) days and upon posting in the Municipal Bulletin Board and other conspicuous places and after publication in a newspaper of local circulation;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all concerned for their information and consideration;




