AN ORDINANCE REQUIRING PERSONS/PERSONS TO PAY FORTY PESOS  
(P40.00) FOR THE PROCESSING OF PAPERS FOR LATE REGISTRATION  
OF ILLEGITIMATE AND LEGITIMATE LIVE BIRTHS OF CHILDREN  
PURSUANT TO CIRCULAR NO. 92-01 CIVIL REGISTRAR GENERAL, NATIONAL  
STATISTICS OFFICE.

On motion of Member Jose Bernardino, duly seconded,  
the Sangguniang Bayan of Solsona, Ilocos Norte Ordains  
that;

Section 1 - The processing of papers of late regis-  
tration of illegitimate and legitimate live birth of chil-  
dren shall pay FORTY PESOS (P40.00) as per Circular No.  
92-01 of the Civil Registrar General, National Statistics  
Office;

Section 2 - This Ordinance shall take effect after  
the lapse of ten days (10) from the date a copy of it is  
posted in a bulletin board, located in a conspicuous place  
in the Municipal Hall, The Public Market, The different  
churches and waiting sheds;
