MUNICIPAL ORDINANCE NO. 450

AN ORDINANCE IMPOSING FEE OF THREE HUNDRED PESOS
(P300.00) AS FILING FEE OF APPLICANTS FOR FRANCHISE
TO OPERATE MOTORIZED TRICYCLE FOR HIRE.

WHEREAS, Article 222, Rule XXI of the RA 7160, empowers
the LGU to impose a tax fee or to generate revenue through an
appropriate tax ordinance or revenue measure;

WHEREAS, due to the meager income being a 5th Class Muni-
cipality, there is an urgent need to augment its income through the
collection of fees on the application of franchise to operate moto-
rized tricycle for hire;

NOW THEREFORE, on motion of Hon. Henry A. Batara, duly
seconded by Hon. Alma Manuel and Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte,
that:

Section 1 - The amount of THREE HUNDRED PESOS (P300.00) as
filing fee to applicants for franchise to operate motorized tricycle
for hire is hereby imposed and collected;

Section 2 - The fees herein levied shall be collected by
the Municipal Treasurer or by an authorized representative;

Section 3 - This tax ordinance shall take effect immediately
after the lapse of twenty-one (21) days from the day a copy of it is
posted on the bulletin board, market and other conspicuous places,
and publish in the newspaper of local circulation;

Copies of this Ordinance be furnished the Sangguniang Panlala-
wigan, Laoag City and the Municipal Treasurer, Solsona, Ilocos Norte;

CARRIED UNANIMOUSLY, with the following votes:






