MUNICIPAL ORDINANCE NO. 463

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE CRB-ILOCOS NORTE, INC., DEPARTMENT OF AGRICULTURE AND NASALUKAG WOMEN'S MULTI PURPOSE COOPERATIVE, INC. FOR THE MULTI-LIVESTOCK DEVELOPMENT LOAN PROGRAM IN THE MUNICIPALITY OF SOLSONA.

WHEREAS, pursuant to the provisions of Article 87, Section VI of the IRR, RA 7160 the Sangguniang Bayan is empowered to grant authorization to the Local Chief Executive to represent the municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made;

WHEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Adlai C. Factora, be it

ORDAINED, by the Sangguniang Bayan in Session, that:

Section 1 - The Local Chief Executive, Hon. Joseph E. de Lara is hereby granted the authority to enter into a Memorandum of Agreement with the CRB-Ilocos Norte, Inc., represented by Editha Susan S.D. Valdez, President/Manager of the Nasalukag Women's Multi-Purpose Cooperative, Inc., Barangay Santiago, Solsona, Ilocos Norte, represented by Anita Benito and the Department of Agriculture, represented by Mr. Lino E. Nazareno, Assistant Secretary of the Department of Agriculture;

Section 2 - This Ordinance shall take effect immediately upon approval;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and to all concerned for their information;


