MUNICIPAL ORDINANCE NO. 47

RE-ARRANGING THE PLACEMENT OF MARKET VENDORS FOR MORE
CONVENIENCE AND BETTER HYGIENE AND SANITATION.

WHEREAS, Market Vendors will have more convenience
if they will stay in their places where they are assigned.
At the same time, vegetables and other food stuffs will be kept
away from foul odor coming from the toilet and the place
where piglets are being sold;

On motion of HON. ANTOLIN D. REFANI, duly seconded
by all the members, be it

ORDAINED by Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - The placement of Market Vendor is hereby
assigned:

a. Vegetable Vendors should stay at the Southern part
of the market building under the acacia tree where the shade
is available;

b. Cloth vendors staying in the Southern portion of
the market should occupy the vacated place of vegetable vendors
at the Northern part of the market;

c. Footwear vendors should clear-up the way going
inside the market and arrange themselves eastward of the
market building;

d. Fish vendors should stay on the cemented stall pro-
vided for;

e. Dried fish, smoked fish and cooked fish should uti-
lize the wooden stall;

Section 2 - Any vendor who will not comply with this
ordinance shall be banned not to sell in the market or be
suspended to sell for one month or longer;

Section 3 - This Ordinance shall take effect with the lapse of ten (10) days from the date, a copy of this is posted in a bulletin board, on a conspicuous place in the market, hall and other public places.




