MUNICIPAL ORDINANCE NO. 477

AN ORDINANCE REQUIRING ALL CONTRACTORS TO REPORT/SUBMIT PROGRAM OF WORKS OF ALL PROJECT CONSTRUCTIONS MADE AND FUNDED BY ANY GOVERNMENT AGENCIES TO THE BARANGAY GOVERNMENT CONCERNED HEADED BY THEIR RESPECTIVE PUNONG BARANGAYS AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, the trust and confidence of the Barangay Folks lies on the Barangay Officials;

NOW THEREFORE, on motion of Hon. Edison E. de Lara, duly seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - All Contractors must submit copies of Program of Works one week before the implementation of the project within the jurisdiction of the barangay to the Barangay Officials headed by the Punong Barangays;

Section 2 - Any Contractor who violates this Ordinance shall be fined of not less than FIVE HUNDRED PESOS (P500.00) but not more than ONE THOUSAND PESOS (P1,000.00) and/or not be allowed to start the project;

Section 3 - This Ordinance shall take effect upon its approval;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, All Barangay Officials thru the Punong Barangays, the Municipal Engineer of Solsona, Ilocos Norte, the District Engineer, Department of Public Works and Highways and others concerned for their information;
