MUNICIPAL ORDINANCE NO.478

AN ORDINANCE REQUIRING ALL HOUSEHOLDS AND BUSINESS ESTABLISHMENTS
TO SEGREGATE THEIR GARBAGE WASTES AND PROVIDING PENALTIES IN
VIOLATION THEREOF.

On motion of Hon. Henry A. Batara, duly seconded by Hon.
Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - All households and business establishments are
hereby required to segregate their garbage wastes;

Section 2 - Garbage intended for collection and disposal by
Municipal Garbage Trucks shall follow the following conditions:

a. Wastes must be separated into dry wastes and wet wastes.
Dry wastes such as papers, plastics, bottles, scraps and wet
wastes such as left over foods and other decomposing and degradable
matters shall be placed inside plastic bags or containers
without leak. These bags and containers shall be brought out in
front of the gates of residential houses and business establish-
ments thirty (30) minutes before the collection schedule. House-
holds in the interior should deposit their wastes along the main
streets accessible to Municipal Garbage Trucks thirty (30) minutes
before the collection schedule;

b. Trees, shrubs and grass cuttings should not be mixed with
the above cited wastes. They should be placed inside a separate
plastic bags or sacks and should follow the disposal process
stated above;

Section 3 - The Municipality shall provide every public
place with 2 waste cans, one for dry wastes and other for wet
wastes;

Section 4 - Throwing or placing of wastes in areas not
designated for such purpose is strictly prohibited;

Section 5 - The Municipal Health Officer shall take the lead in implementing the provisions of this article with the assistance of the police and other persons to be deputized by the Municipal Mayor.

Section 6 - Penalty - Any person who violates any provision of this Article shall be subject to the following penalties:

1st Offense - P150.00 fine or imprisonment depending on the court's discretion;

2nd Offense - P 300.00 fine or imprisonment depending on the court's discretion;

3rd Offense - P1,000.00 fine or imprisonment depending on the court's discretion;

Copies of this Ordinance be furnished the Sangguniang Pambalwigan and others concern for their information and guidance;

CARRIED UNANIMOUSLY, with the following votes:


