MUNICIPAL ORDINANCE NO. 479

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA, TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOODS AUTHORITY (NFA) REPRESENTED BY ITS ADMINISTRATOR JOEMARI D. GEROCHI, MATIMYAS BUILDING, 101 E. RODRIGUEZ SR. AVENUE, QUEZON CITY TO PURCHASE RICE ON CREDIT FROM THE NATIONAL FOODS AUTHORITY (NFA).

WHEREAS, pursuant to the provision of Article 87, Section VI of the IRR, RA 7160, the Sangguniang Bayan is empowered to grant authorization to the Local Chief Executive to represent the municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made;

WHEREFORE, on motion of Hon. Henry A. Batara, duly seconded by Hon. Jovencio M. Pascua and Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Local Chief Executive, Hon. Joseph E. de Lara, is hereby granted the authority to enter into a Memorandum of Agreement with the National Foods Authority, (NFA) represented by its Administrator, Mr. Joemari D. Gerochi, herein referred to as NFA, to Purchase Rice on Credit from the National Foods Authority (NFA), Matimyas Bldg., 101 E. Rodsriguez Sr. Avenue, Quezon City;

Section 2 - This Ordinance shall take effect immediately upon approval;

Copies of this Ordinance be furnished the Sangguniang Panlawigan, Laoag City and the National Foods Authority, thru Mr. Joemari D. Gerochi, Matimyas Bldg., 101 E. Rodriguez Sr. Avenue, Quezon City for their information and consideration;


