MUNICIPAL ORDINANCE NO. 481

AN ORDINANCE GRANTING 15% INCENTIVE OUT OF THE PENALTIES DERIVED FROM VIOLATED MUNICIPAL ORDINANCES TO ALL PNP PERSONNEL OF SOLSONA, ILOCOS NORTE, FOR EVERY APPREHENSION MADE.

WHEREAS, the Municipal Mayor has exerted more efforts in making the Municipality better, safer and more beautiful place to live in;

WHEREAS, in the realization of the above, the Local Legislative Body has enacted various Municipal Ordinances concerning peace, orderliness, cleanliness and beautification;

WHEREAS, the Municipality of Solsona had been a consistent performer in the above aspects not only in the province but also in the Regional and National Levels;

WHEREAS, in order to maintain the present peaceful, orderly situation and clean environment of the community, there is a need to inspire the Law Enforcers more to do better in the performance of their duties and functions;

NOW THEREFORE, on motion of Hon. Agripino M. Estavillo, duly seconded by Hon. Adlai C. Factora, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte;

Section 1 - To grant 15% incentive out of the Penalties derived from violated Municipal Ordinances to all PNP Personnel of Solsona, Ilocos Norte, for every apprehension made;

Section 2 - This Ordinance shall take effect immediately upon its approval;
