MUNICIPAL ORDINANCE NO. 482

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA, TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF NATURAL RESOURCES (DENR) REPRESENTED BY UNDERSECRETARY HON. DELFIN GANAPIN JR. TO MUTUALLY AGREE AND BIND THEMSELVES TO UNDERTAKE A PROJECT WHICH SHALL BE CALLED "INTEGRATED ENR DEVELOPMENT PROJECT".

WHEREAS, pursuant to the provision of Article 87, Section VI of the IRR, RA 7160 the Sangguniang Bayan is empowered to grant authorization to the Local Chief Executive to represent the Municipality in all its business transactions and signs it behalf all bonds, contractors and obligations and such other documents made;

WHEREFORE, on motion of Hon. Henry A. Batara, duly seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte that:

Section 1 - The Local Chief Executive, Hon. Joseph E. de Lara to represent the Municipality of Solsona, Ilocos Norte to enter into a Memorandum of Agreement with the Department of Environmental and Natural Resources (DENR) represented by its Undersecretary Hon. Delfin Ganapin Jr. to mutually agree and bind themselves to undertake a project which shall be called "Integrated ENR Development Project".

Section 2 - This Ordinance shall take effect immediately upon approval.


