MUNICIPAL ORDINANCE NO. 483

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA, TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE NO. 1 REPRESENTED BY ITS REGIONAL DIRECTOR HON. ROGELIO V. SIGNEY WITH OFFICE ADDRESS AT AGUILA ROAD SAN FERNANDO, LA UNION FOR THE AVAILMENT OF ONE UNIT MOTORCYCLE UNDER THE SECOND COMMUNAL IRRIGATION DEVELOPMENT PROJECT (CIDP II) IN THE MUNICIPALITY OF SOLSONA.

Whereas, pursuant to the provision of Article 87, Section VI of the Local Government Code of 1991, the Sangguniang Bayan is empowered to grant authorization to the Local Chief Executive to represent the Municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made;


Whereas, the Municipality of Solsona is a benefactor of the Second Communal Irrigation Development Project (CIDP II) which is being funded by the World Bank to be implemented by the Department of Agriculture with the National Irrigation Administration;

Wherefore, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Jovencio M. Pascua, be it

Ordained by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1- The Local Chief Executive, Hon. Joseph E. de Lara is hereby granted the authority to Enter Into A Memorandum of Agreement representing the Municipality of Solsona, with the Department of Agriculture, Regional Field Office No. I, represented by its Regional Director Hon. Rogelio V. Signey with office address at Aguila road San Fernando, La union for the availment of one unit Motorcycle under the Second Communal Irrigation Development Project (CIDP II) in the Municipality of Solsona;

Section 2- This Ordinance shall take effect immediately upon approval;






