MUNICIPAL ORDINANCE 484

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA, TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL IRRIGATION ADMINISTRATION REPRESENTED BY ITS REGIONAL IRRIGATION MANAGER ENGINEER LEODENCIO I. BARAQUIO WITH OFFICE ADDRESS AT NATIONAL IRRIGATION ADMINISTRATION, SAN FERNANDO, LA UNION FOR THE SECOND IRRIGATION OPERATION SUPPORT PROJECT (IOSP II) IS SOLSONA, ILOCOS NORTE.

WHEREAS, pursuant to the provision of Article 87, Sec. VI of the Local government Code of 1991, the Sangguniang Bayan is empowered to grant authorization to the Local Chief Executive to represent the Municipality of all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made;

WHEREAS, the Municipality is a recipient of the second IOSP to be implemented jointly by the Local government Unit (LGU) and National Irrigation Administration (NIA);

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Local Chief Executive Hon. Joseph E. de Lara of the Municipality of Solsona is hereby granted the authority to Enter Into A Memorandum of Agreement with the National Irrigation Administration represented by its Regional Irrigation Manager Engineer Leodencio I. Baraquio with office address at National Irrigation Administration, San Fernando, La Union for the implementation of the Second Irrigation Operation Support Project (IOSP II) in the Municipality of Solsona, Ilocos Norte;

Section 2 - This Ordinance shall take effect immediately upon approval;




