MUNICIPAL ORDINANCE NO. 485

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH, THRU THE SECRETARY, MANILA, REPRESENTED BY CONRADO K. GALSIM JR., OF THE REGIONAL HEALTH FIELD OFFICE, NO. 1 SAN FERNANDO LA UNION, WITH HIS CAPACITY AS A DIRECTOR IV, HEREIN REFERRED TO AS DEPARTMENT OF HEALTH, THAT THE DEPARTMENT OF HEALTH SHALL PROVIDE THE SUBSIDIES TO THE LOCAL GOVERNMENT UNITS TO PARTIALLY COVER MAGNA CARTA BENEFITS OF ALL DEVOLVED HEALTH WORKERS FOR THE YEAR 1995.

WHEREAS, pursuant to the provision of Article 87, Section VI of the Local Government Code of 1991, the Sangguniang Bayan is empowered to grant authorization to the Local Chief Executive to represent the Municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made;

WHEREAS, the Department of Health shall provide subsidies to the Local Government Units to partially cover Magna Carta benefits of all devolved health workers for the year 1995;

WHEREFORE, on motion of Hon. Henry A. Batara and duly seconded by Hon. Ismael L. Agulay, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Local Chief Executive Hon. Joseph E. de Lara, Solsona, Ilocos Norte is hereby granted the authority to Enter Into A Memorandum of Agreement with the Department of Health through the Secretary represented by Conrado K. Galsim Jr., Regional Field Office, No. 1 San Fernando, La Union for his capacity as Director IV of the Department of Health;

Section 2 - This Ordinance shall take effect immediately upon approval;




