**MUNICIPAL ORDINANCE NO. 486**

**AN ORDINANCE REQUIRING ALL DRIVERS OF TRICYCLE FOR HIRE WHO ARE OPERATING IN THE MUNICIPALITY OF SOLSONA TO HAVE AN IDENTIFICATION CARD TO BE POSTED INSIDE THEIR SIDECARS AND PROVIDING PENALTIES IN VIOLATION THEREOF.**

WHEREAS, it is the main concern of the Sangguniang Bayan to look for the betterment of the drivers of tricycle for hire as well as the riding public;

WHEREAS, the identification card will provide the proper identity of the tricycle drivers which entails their personal data to all passengers especially to visitors;

NOW THEREFORE, on motion of Hon. Adlai C. Factora, duly seconded by Hon. Gervacio B. Vicente, be it,

ORDAINED, by the Sangguniang Bayan in session that :

Section 1 - All drivers of tricycle for hire who are operating within the jurisdiction of Solsona are required to have an identification card to be posted inside their sidecars;

Section 2 - The identification card entails the name of the driver, sex, age, date of birth, birth place, civil status, residence and the signature of the Driver and the Association President;

Section 3 - All drivers shall have common identification card, size 4"x6" to be provided by the tricycles' Association;

Section 4 - Violation of this Ordinance shall subject the driver a penalty of not less than **TWO HUNDRED PESOS (P200.00)** but not more than **FIVE HUNDRED PESOS (P500.00)** or an imprisonment of fifteen (15) days or both upon the discretion of the court;

Section 5 - This Ordinance shall take effect immediately after the lapse of twenty-one (21) days after posting copies in three (3) conspicuous places and upon publication in a newspaper of local circulation;

Copies of this Ordinance be furnished the Municipal Treasurer, Solsona, Ilocos Norte, the STODA Members, thru the President, Mr. Loreto Paraiso, Solsona, Ilocos Norte and the Sangguniang Panlalawigan, Laoag City for their information and consideration;


