MUNICIPAL ORDINANCE NO. 488

AN ORDINANCE IMPOSING RENTAL FEES OF FIFTY PESOS (P50.00) PER MONTH FOR EVERY UNIT OF THE BUILDINGS IN THE BLISS SITE LOCATED AT BARANGAY # 10, MANALPAC, SOLSONA, ILOCOS NORTE.

WHEREAS, the buildings in the BLISS Site were already turn-over to the Municipality of Solsona, Ilocos Norte in 1996 by the BLISS Development Corporation, Baguio City;

WHEREAS, the Municipal Government is paying a monthly amortization of TWO THOUSAND NINE HUNDRED FORTY PESOS (P2,940.00) to the BLISS Development Corporation;

WHEREAS, the Municipal Government deemed it necessary to require the occupants to pay their rental fees per month in order to compensate with the Government's monthly amortization;

WHEREFORE, on motion of Hon. Gervacio B. Vicente duly seconded by Hons. Jovencio M. Pascua, Andresito A. Luis and Adlai C. Factora, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - a rental fee of FIFTY PESOS (P50.00) per month be imposed for every unit of the buildings in the BLISS Site located at Barangay # 10, Manalpac, Solsona, Ilocos Norte;

Section 2 - this Ordinance shall take effect 21 days after posting in a conspicuous places and upon its approval;

Copies of this Ordinance be furnished the Municipal Treasurer, Solsona, Ilocos Norte and the Sangguniang Panlalawigan, Laoag City for their information and consideration;


