**MUNICIPAL ORDINANCE NO. 489**

**AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR, HON. JOSEPH E. DE LARA, TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF ILOCOS NORTE REPRESENTED BY THE PROVINCIAL GOVERNOR, HON. RODOLFO C. FARIÑAS, AND THE NASALUKAG WOMEN'S MULTI-PURPOSE COOPERATIVE INC. OF BARANGAY SANTIAGO, SOLSONA, ILOCOS NORTE FOR THE LOAN ASSISTANCE PROJECT.**

WHEREAS, the Sangguniang Bayan is empowered to grant authorization to the Municipal Mayor to represent the Municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents made, as mandated in the provisions of Article 87, Section VI of the IRR, RA 7160;

WHEREFORE, on motion of Hon. Edison E. de Lara, duly seconded by Hon. Gervacio B. Vicente and Hon. Adlai C. Factora, be it,

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte that :

Section 1 - The Local Chief Executive, Hon. Joseph E. de Lara is hereby granted the authority to enter into a Memorandum of Agreement with the Provincial Government of Ilocos Norte, represented by the Provincial Governor, Hon. Rodolfo C. Fariñas and the President/Manager, Mrs. Anita Benito of the Nasalukag Women's Multi-Purpose Cooperative, Incorporated, Barangay Santiago, Solsona, Ilocos Norte, for the Loan Assistance Project;

Section 2 - This Ordinance shall take effect immediately upon its approval;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and to all concerned for their information and consideration;


