MUNICIPAL ORDINANCE NO. 49

AN ORDINANCE REQUIRING ALL APPLICANTS OF MAYOR'S
PERMIT TO SUBMIT A BARANGAY CLEARANCE AS A PRE-
REQUISITE THERETO.

On motion of Hon. Henry A. Batara, duly seconded
by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona,
Ilocos Norte, that:

Section 1 - The provisions of existing ordinances
to the contrary notwithstanding, no Mayor's Permit shall
be issued to any applicant thereof unless said applicant
shall first secure a clearance from the Barangay where
he/she resides or where he/she proposes to conduct business
or practice a profession or occupation;

Section 2 - The Barangay Clearance shall be issued
by the Punong Barangay concerned or by his duly authorized
representative, after payment by the applicant to the Baran-
gay Treasurer, the amount which is determined by the Barangay
Council by enacting an Ordinance;

Section 3 - Any person who violates this Ordinance
or who, as officials or employees, induces or knowingly
allows the violation of this Ordinance shall, upon convic-
tion, be punished with Arresto Mayor in its medium period
to prison correctional in its minimum period, and a fine of
not exceeding ONE THOUSAND PESOS (P1,000.00);

Section 4 - The distribution of copies of this
Ordinance be furnished the Municipal Treasurer, the Licensing
Department, Solsona, Ilocos Norte, the Sangguniang Panlalawi-
gan, Laoag City, for their information;

Section 5 - This Ordinance shall take effect ten
(10) days after publication;




