MUNICIPAL ORDINANCE NO. 490

**AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE OCCUPANTS OF THE BUILDING IN THE BLISS SITE IN BARANGAY 10, MANALPAC, SOLSONA, ILOCOS NORTE.**

WHEREAS, pursuant to the provision of Article 87, Section VI of the Local Government Code of 1991, the Sangguniang Bayan is empowered to grant authorities to the Local Chief Executive to represent the Municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents made;

WHEREFORE, on motion of Hon. Gervacio B. Vicente, duly seconded by Hon. Alma B. Manuel, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that

Section 1 - The Local Chief Executive, Hon. Joseph E. de Lara of the Municipality of Solsona is hereby granted the authority to enter into a Memorandum of Agreement with the occupants of the building in the BLISS Site in Barangay Manalpac, Solsona, Ilocos Norte;

Section 2 - This Ordinance shall take effect immediately upon approval;




