MUNICIPAL ORDINANCE NO. 492

AN ORDINANCE REQUIRING ALL HOUSEHOLDS OF SOLSONA, ILOCOS NORTE TO HAVE A ONE (1) DAY GENERAL CLEANING OF EVERY MONTH, OUTSIDE RESIDENTS, ALONG THOROUGH-FARES, CANALS AND OTHER AREAS THAT NEED CLEARING AND CLEANING AND PROVIDED PENALTIES IN VIOLATION THEREOF.

WHEREAS, one of the main thrusts of the present administration of Solsona is the full implementation of the Clean and Green Program;

WHEREAS, the presence of a clean and green environment is a sign of a healthy, happy and progressive citizens;

NOW THEREFORE, on motion of Hon. Alma B. Manuel duly seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - All households of Solsona, Ilocos Norte are hereby required to have a one (1) day general cleaning of every month outside their residents, along thoroughfares, canals and other areas that need clearing and cleaning;

Section 2 - Anybody who shall violate this Ordinance shall be fined of not less than THREE HUNDRED PESOS (P300.00) but not more than FIVE HUNDRED PESOS (500.00) or both fine and imprisonment upon the discretion of the Court;

Section 3 - The Barangay Treasurers shall be authorized to collect the fines with a 50-50 share with the Municipal Government;

Section 4 - The Barangay Government shall be delegated to implement this Ordinance;

Section 5 - This Ordinance shall take effect upon the lapse of twenty (21) days after posting copies in conspicuous places, like in the Municipal Bulletin Board, Church and Barangay Hall and after publication in a local newspaper for three (3) successive weeks;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and all concerned for their information and consideration;

CARRIED UNANIMOUSLY, with the following votes:




