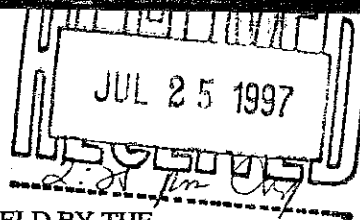

MUNICIPAL ORDINANCE NO. 493

AN ORDINANCE REQUIRING ALL TRANSIENT BUYERS OF LIVESTOCK AND ALL
AGRICULTURAL PRODUCTS TO SECURE PERMIT FROM THE OFFICE OF THE
MAYOR AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, a business form engaged in agricultural products is a free enterprise, however, the Municipal Government is obliged to raise revenue in order to attain the goals and objectives;

WHEREAS, transient buyers of livestock, poultry and other agricultural products are taking advantage of the low prices of commodities in the locality and tend to sell their purchased goods outside the town;

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Andresito A. Luis, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - There shall be collected Mayor's Permit Fee of ONE HUNDRED FIFTY PESOS (P150.00) from each transient buyer of livestock and other agricultural products within the jurisdiction of the Municipality of Solsona, Ilocos Norte;

Section 2 - The fee shall be paid to the Municipal Treasurer and/or Barangay Treasurer by the Transient Buyers engaged in buying operations;

Section 3 - The securing of a Mayor's Permit shall be done annually;

Section 4 - The Mayor's Permit shall not be transferable;

Section 5 - Any violation of the provisions of this Ordinance shall be punished by a fine of not less than ONE THOUSAND PESOS (P1,000.00) or an imprisonment of not less than twenty (20) days or both fine and imprisonment at the discretion of the Court;

Section 6 - This Ordinance shall take effect after the lapse of twenty -one (21) days and after posting in three (3) conspicuous places and upon publication in a newspaper of local circulation;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, the Municipal Treasurer, Solsona, Ilocos Norte and the Chief of Police, Philippine National Police, Solsona, Ilocos Norte, for their information and consideration;

CARRIED UNANIMOUSLY, with the following votes:


