MUNICIPAL ORDINANCE NO. 494

AN ORDINANCE REQUIRING ALL PERSONS, FIRM OR CORPORATION INVOLVED IN THE CONSTRUCTION, REPAIR OR DEMOLITION OF BUILDING OR ANY STRUCTURE TO POST THE BUILDING PERMIT NUMBER AND AUTHORIZING THE BARANGAY OFFICIALS TO DETECT AND REPORT ILLEGAL CONSTRUCTION.

WHEREAS, it has been the problem of the Municipal Building Official and Deputized Zoning Administrator that illegal construction, repair and demolition of building or any structure within the Municipality of Solsona has not reported to authorities concerned;

WHEREAS, it has been the problem of the Deputized Municipal Building Official and Zoning Administrator that the illegal construction, repair and demolition of building or structure in the barangays are not reported to the authorities concerned;

WHEREFORE, on motion of Hon. Edison E. de Lara duly seconded by Hon. Henry A. Batara, be it:

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte that :

Section 1 - All person, firms or corporation involved in the construction, repair or demolition of building or any structure is hereby required to post the building permit number on a conspicuous place within the construction site;

Section 2 -All Sangguniang Barangay Officials headed by their respective Punong Barangay are required to detect illegal construction, repair and/or demolition of any building or structure within their area of jurisdiction and report to the same authorities concerned;

Section 3 - Building Permit, Zoning Clearance should be secured first before such construction, repair or demolition is to be done and the Sangguniang Barangay headed by the Punong Barangay concerned shall demand the person, firm or corporation engaged thereto the presentation of permit issued;

Section 4 - None posting of Building Permit Number will be fined of not less than P500.00 but not more than P1,000.00 or an imprisonment of 30 days to six months or both fine and imprisonment upon the description of the court.

Section 5 - This ordinance shall take effect after the lapse of 21 days upon posting in the Municipal Bulletin Board or other conspicuous places and after publication in a newspaper of local circulation.

Copies of this ordinance be furnished the Sangguniang Panlalawigan, Laoag City for their information and consideration.


