MUNICIPAL ORDINANCE NO. 496

AN ORDINANCE REQUIRING ALL APPLICANTS OF ZONING CLEARANCE AND BUILDING PERMIT TO SECURE A BARANGAY CLEARANCE AS A PRE-REQUISITE THERETO AND PROVIDING PENALTIES IN VIOLATION THEREOF.

On motion of Hon. Henry A. Batara, duly seconded by Hon. Edison E. de Lara, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - A Barangay Clearance shall be required as a pre-requisite in the issuance of a Zoning Clearance and Building Permit;

Section 2 - The Barangay Clearance shall be secured by the applicant from the barangay where he/she resides;

Section 3 - The Barangay Clearance shall be issued by the Punong Barangay concerned or by his duly authorized representative, after payment by the applicant to the Barangay Treasurer;

Section 4 - Any person who violates this Ordinance shall be fined of not exceeding ONE THOUSAND PESOS (P1,000.00) or an imprisonment of 30 days but not more than 6 months or both fine and imprisonment depending upon the discretion of the court;

Section 5 - This Ordinance shall take effect after the lapse of twenty-one (21) days from the day a copy of it is posted in three (3) conspicuous places and upon publication in a newspaper of local circulation;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, the Municipal Building Official, the Deputized Zoning Administrator, Solsona, Ilocos Norte and to all concerned for their information and consideration;


