MUNICIPAL ORDINANCE NO. 497

AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR, HON. JOSEPH E. DE LARA, TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ACCEPT A PARCEL OF LAND LOCATED IN BARANGAY MAANANTENG, SOLSONA, ILOCOS NORTE FOR USE AS A MUNICIPAL CEMETERY OF SOLSONA, ILOCOS NORTE, DONATED BY SB MEMBER ALMA B. MANUEL AND MS. ANUNCIACION B. MANUEL, LEGAL HEIRS OF THE LATE INOCENCIO MANUEL.

WHEREAS, SB Member Alma B. Manuel and Ms. Anunciacion B. Manuel, the only legal Heirs of the late Inocencio Manuel manifest their desire to transfer and convey and donate, a parcel of land located in Barangay Maananteng, Solsona, Ilocos Norte for use as a Municipal Cemetery of the Municipality of Solsona, Ilocos Norte;

NOW THEREFORE, on motion of Hon. Henry A. Batara, seconded by Hon. Edison E. de Lara, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Municipal Mayor, Hon. Joseph E. de Lara is hereby given the authority to accept a parcel of land located in Barangay Maananteng, Solsona, Ilocos Norte, for use as a Municipal Cemetery of Solsona, Ilocos Norte, donated by SB Member Alma B. Manuel and Ms. Anunciacion B. Manuel, legal heirs of the late Inocencio Manuel ;


Section 2 - This Ordinance shall take effect immediately;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, for their information and consideration;
