**MUNICIPAL ORDINANCE NO. 497** 

AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR, HON. JOSEPH E. DE LARA, TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ACCEPT A PARCEL OF LAND LOCATED IN BARANGAY MAANANTENG, SOLSONA, ILOCOS NORTE FOR USE AS A MUNICIPAL CEMETERY OF SOLSONA, ILOCOS NORTE, DONATED BY SB MEMBER ALMA B. MANUEL AND MS. ANUNCIACION B. MANUEL, LEGAL HEIRS OF THE LATE INOCENCIO MANUEL.

Manuel and Ms. Anunciacion B. Manuel, legal heirs of the late Inocencio Manuel;
