MUNICIPAL ORDINANCE NO. 498

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE, TO DONATE A LOT OWNED BY THE MUNICIPALITY WEST OF THE BUTEL BUILDING WITH AN AREA OF 460 SQ.M. FOR THE CONSTRUCTION OF PNP BUILDING.

WHEREAS, in view of the desire of the Philippine National Police of Solsona, Ilocos Norte to have a building of their own, the Municipality is willing to donate a lot owned by the municipality with an area of 460 sq.m. more or less located at the west of the BUTEL Building;

WHEREFORE, on motion of Hon. Gervacio B. Vicente, duly seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Local Chief Executive, Hon. Joseph E. de Lara is hereby authorized to represent the Municipality of Solsona, Ilocos Norte to donate a lot owned by the Municipality west of the BUTEL Building with an area of 460 sq.m. more or less for the construction of a PNP Building;

Section 2 - This Ordinance shall take effect immediately upon its approval;


Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, the Local Chief Executive, Hon. Joseph E. de Lara, and the Chief of Police, PNP, Solsona, Ilocos Norte, for their information and consideration;
