MUNICIPAL ORDINANCE NO. 499

AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR, HON. JOSEPH E. DE LARA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRARIAN REFORM (DAR) AND THE BUREAU OF LOCAL GOVERNMENT FINANCE (BLGF) FOR THE EXECUTION OF SUBPROJECTS UNDER THE AGRARIAN REFORM COMMUNITIES DEVELOPMENT PROJECT (ARCDP).

WHEREAS, the Agrarian Reform Communities (ARC) of Solsona, Ilocos Norte composing of four (4) barangays namely, Catangraran, Manalpac, Nagpatpatan and Sta. Ana are recipients of Infrastructure Projects under the World Bank assisted project of the National Government through the Department of Agrarian Reform;

WHEREFORE, on motion of Hon. Jovencio M. Pascua, duly seconded by Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Municipal Mayor, Hon. Joseph E. de Lara, Solsona, Ilocos Norte, is hereby authorize to enter into a Memorandum of Agreement with the Department of Agrarian Reform (DAR) and the Bureau of Local Government Finance (BLGF) for the execution of the Sub-Projects under the Agrarian Reform Communities Development Projects (ARCDP);


Section 2 - This Ordinance shall take effect immediately upon its approval;

Copies of this Ordinance be furnished the Provincial Project Director, Atty. Rogelio C. Arquillo, Department of Agrarian Reform, Laoag City for endorsement to the Central Project Office, Manila and the Sangguniang Panlalawigan, Laoag City, for their information and consideration;


