MUNICIPAL ORDINANCE NO. 50

AN ORDINANCE AMENDING TAX ORDINANCE 01, CHAPTER IV,
ARTICLE B, SECTION 3B.01-A NO. 3 OF THE REVENUE TAX CODE
OF SOLSONA, ILOCOS NORTE, INCREASING THE MARRIAGE SOLEMNI-
ZATION FEE FROM TEN PESOS (P10.00) TO THIRTY PESOS (P30.00)

On motion of Hon. Rogerio E. Teodoro, duly seconded
by Hon. Henry A. Batara, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - The Marriage Solemnization fee be increased
to THIRTY PESOS (P30.00) from the current fee of TEN PESOS;

Section 2 - The fee shall be paid to the Municipal
Treasurer or her duly authorized representative before the
registration of a document or issuance of the license; or

Section 3 - Any violation of this Ordinance shall
be punished by a fine of not less than FIFTY PESOS (P50.00)
but not exceeding ONE HUNDRED PESOS (P100.00) OR imprisonment
of not less than ten (10) days but not exceeding twenty days
(20) or both at the discretion of the court;

Section 4 - Any Ordinance contrary or in conflict
with the foregoing provisions of this Ordinance are hereby
repealed or resigned;

Section 5 - This Ordinance shall take effect after
the lapse of ten (10) days from the day a copy of it is posted
in a bulletin board located in a conspicuous place at the Muni-
cipal Hall, public market and to be published in the Newspaper
as required by law and upon approval of the Sangguniang Panla-
lawigan, Laoag City;
