MUNICIPAL ORDINANCE NO. 501

AN ORDINANCE AUTHORIZING THE HONORABLE JOSEPH E. DE LARA, MAYOR OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE IGNACIO R. BUNYE, CITY MAYOR OF MUNTINLUPA FOR THE INSTALLATION AND MAINTENANCE OF THE RPTA DATA COMPUTERIZATION AND TAX COLLECTION PROGRAM OF THE MUNICIPAL GOVERNMENT OF SOLSONA, ILOCOS NORTE.

WHEREAS, the entire official of the Municipal Government of Solsona, Ilocos Norte is desirous to adopt the RPTA Computerized System of the City of Muntinlupa, which has been chosen by the Department of Finance to be the model RPTA Computerized System for all the Assessor's and Treasury Office to the whole Philippines;

WHEREAS, to enable the Municipal Government of Solsona to successfully adopt and perfect the same system, it is the imperative for the Local Government Unit to enter into a Memorandum of Agreement with the City Government of Muntinlupa, for the installation and maintenance of the RPTA Computerization and Tax Collection Program of the Municipal Government;

NOW THEREFORE, on motion of Hon. Henry A. Batara, duly seconded by Hon. Jovencio M. Pascua, be it;

Section 2- This Ordinance shall take effect upon its approval;




