MUNICIPAL ORDINANCE NO. 502

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. BERTHA L. DE LARA TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOODS AUTHORITY (NFA) TO PURCHASE RICE ON CREDIT WITH THEM.

WHEREAS, pursuant to the provision of Article 87, Section VI of the Local Government Code of 1991, the Sangguniang Bayan are empowered to grant authorization to the Local Chief Executive to represent the municipality in all its business transactions and sign in its behalf all bonds contracts and obligations and such other documents made;

WHEREAS, the municipal government is very much aware of the onslaught of the LA NIÑA PHENOMENON and the devastating effect it would bring to our constituents in the depressed areas;

WHEREAS, there is an imperative need to enact measures necessary for relief operations;

WHEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 The Local Chief Executive Hon. Bertha L. de Lara is hereby granted the authority to Enter into a Memorandum of Agreement with the National Foods Authority (NFA), represented by its Provincial Manager, Arturo V. Figueroa, herein referred to as National Foods Authority (NFA), to purchase rice on credit at the National Foods Authority (NFA) for the Municipality's relief operation whenever a state of calamity is declared;

Section 2 This Ordinance shall take effect immediately upon approval.

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and the Provincial Manager, Mr. Arturo Figueroa, National Foods Authority, Laoag City, for their information;


