MUNICIPAL ORDINANCE NO. 503

AN ORDINANCE INCREASING THE INCENTIVES OF PERSONS IN THE APPREHENSION OF VIOLATORS DERIVED FROM PENALTIES INCURRED ON MUNICIPAL ORDINANCES FROM 15% TO 30%.

WHEREAS, private citizens mostly to non-government organizations are very much active in helping the Local Peace Official particularly the PNP in the implementation of existing ordinances with concomitance to environmental sanitation;

WHEREAS, the Legislative Body preferred to increase the incentive of PNP personnel and private citizens involved in the apprehension of violators of the municipality's existing ordinances;

NOW THEREFORE, on motion of Hon. Ismael L. Agulay, duly seconded by Hon. Jovencio M. Pascua and Hon. Gervacio B. Vicente, be it

ORADAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that :

Section 1 : The incentives of PNP personnel or any private citizen in the Municipality of Solsona involved in the apprehension of violators of ordinances is hereby increased from 15% to 30% derived from penalty imposed collected by the Office of the Municipal Treasurer or his duly authorized representative;

Section 2 - This ordinance shall repeal all ordinances relative to environmental sanitation in part or in whole;

Section 3 - This ordinance shall take effect upon approval and all the provisions of the Local Government Code pertaining to shall be complied with;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, for their information and consideration;
